ASSIGNMENT

WHEREAS, ASSIGNOR wishes to assign all worldwide rights, title and interest it may have in and to the trademarks, service marks, trade names and domain names listed on the attached Exhibit A, including all U.S. and foreign applications and registrations therefore, all common law rights associated therewith, and all goodwill associated thereby (collectively referred to as the "Marks"); and
