I, Gregory Handschuh, declare and state as follows:


1. At the time of registration of the subject trademark (January 28, 1997), I was Vice President, General Counsel and Secretary of Amdahl Corporation (now known as Fujitsu IT Holdings, Inc.) and a member of the Board of Directors of AmSub, Inc.

2. I have personal knowledge of the facts set forth in this declaration, and could testify competently thereto if called upon to do so.
