- 1 **Adis International Limited** a duly incorporated company under New Zealand law and having its registered office in Auckland, New Zealand (“**Adis**”).
- 2 **Adis International, Inc.** a duly incorporated company under United States law and having its registered office in Pennsylvania, United States (“**Adis USA**”).

## Background

- A Adis is the registered proprietor and applicant for registration of the trade marks set out in the attached Schedule (“the United States Trade Marks”).
- B Adis inadvertently caused to be filed with the United States Patent and Trademark Office documentation evidencing assignment of the United States Trade Marks from Adis USA to Adis (the “Filing”). For purposes of reversing the Filing, Adis has agreed to assign to Adis USA the United States Trade Marks and all rights pertaining thereto, together with the goodwill of the business associated therewith, for the consideration referred to herein. The intent of this Deed is to evidence that Adis and Adis USA never intended for the United States Trade Marks to be assigned from Adis USA to Adis, and that no financial consideration has been exchanged by the parties.

## Operative Part

### Assignment

In consideration of the foregoing and other adequate and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Adis as beneficial owner hereby assigns, from 30 June 2002, to Adis USA all the United States Trade Marks and all the estate, right, title, interest, benefit, property, claim and demand of Adis and all its rights, remedies and powers in respect thereof, together with the goodwill of the business associated therewith, to hold absolutely.
