ASSIGNMENT OF TRADEMARKS

This Trademark Assignment is effective as of April 18, 2000 and is pursuant to an Agreement made on April 12, 2000 between the parties herein.

WHEREAS, ACCESS PRODUCT MARKETING, LLC (assignee of Access Sales and Marketing LLC), a Georgia limited liability company, having a principal place of business at 338 Main Street, Chester, New Jersey 07930, (hereinafter referred to as "ASSIGNOR"), is the owner of the trademark and record owner of the United States trademark Registration No. 2,687,547, (hereinafter referred to as the "TRADEMARK"); and

WHEREAS, WAL-MART STORES, INC., a Delaware corporation, having a principal place of business at 702 SW 8th Street, Bentonville, Arkansas 72716 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring all of the right, title and interest of ASSIGNOR in, to and under the TRADEMARK, together with the goodwill of the business associated with the TRADEMARK or portion thereof to which the TRADEMARK pertains; and

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR hereby transfers and assigns to ASSIGNEE the entire right, title and interest of ASSIGNOR in and to the TRADEMARK together with the goodwill of the business associated with the TRADEMARK or portion thereof to which the TRADEMARK pertains and the United States and foreign registrations and applications, thereof; and

ASSIGNOR, does hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the


TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representative;

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States to record the TRADEMARK as the property of ASSIGNEE; and

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARK and registrations and applications herein assigned.
