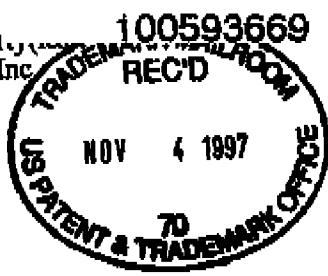

**ASSIGNMENT**

This Assignment is made effective as of August 29, 1997 by Community Bankshares, Inc., a New Hampshire corporation ("Community"), in favor of CFX Corporation, a New Hampshire corporation ("CFX"), and by Concord Savings Bank, a New Hampshire state-chartered savings bank, and Centerpoint Bank, a New Hampshire state-chartered commercial bank (collectively, the "Community Banks"), in favor of CFX Bank, a New Hampshire state-chartered savings bank (collectively, Community and the Community Banks are referred to herein as "Assignors");

WHEREAS, Assignors own all right, title and interest in and to the marks and names listed in Attachment 1 for use in connection with the banking services and other financial products and services listed in that Attachment (collectively, such marks and names, together with the goodwill symbolized thereby and the registrations for those Marks listed in Attachment 1, are referred to herein as the "Marks");

WHEREAS, in connection with the acquisition of Assignors (the "Acquisition") pursuant to an Agreement and Plan of Reorganization and related Plan of Share Exchange, both dated as of March 24, 1997, CFX will acquire by operation of law any and all of Community's right, title and interest in and to, and CFX Bank will acquire by operation of law any and all of the Community Banks' right, title and interest in and to, the Marks and any copyrights and other proprietary rights that Assignors, or any of them, own in any works that they have used in conducting their business and operations (the "Works"), and Community and the Community Banks have executed this Assignment to confirm such acquisitions by operation of law.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, and intending to be legally bound hereby, Assignors agree as follows:

1. Community hereby irrevocably assigns, transfers, conveys and grants to CFX: (a) any and all worldwide right, title, and interest now owned and possessed by Community in and to the Marks; (b) any and all worldwide right, title and interest in and to any other proprietary rights, including but not limited to copyrights, that Community now owns in the Works; and (c) all rights of action at law and suits in equity to recover for past infringements of one or more of the Marks and of any proprietary rights, including but not limited to copyrights, in the Works.

2. Each of the Community Banks hereby irrevocably assigns, transfers, conveys and grants to CFX Bank: (a) any and all worldwide right, title, and interest now owned and possessed

by it in and to the Marks; (b) any and all worldwide right, title and interest in and to any other proprietary rights, including but not limited to copyrights, that it now owns in the Works; and (c) all rights of action at law and suits in equity to recover for past infringements of one or more of the Marks and of any proprietary rights, including but not limited to copyrights, in the Works.

3. If at any time CFX or CFX Bank shall consider or be advised that any further assignments, conveyances or assurances are necessary or desirable to vest, perfect or confirm in CFX or CFX Bank all right, title or interest in or to the Marks or the Works, the proper officers and directors of Community and the Community Banks, as of the effective date of the Acquisition, and thereafter the officers of CFX and CFX Bank, acting on behalf of Community and the Community Banks, shall execute and deliver any and all proper assignments, conveyances and assurances, and do all things necessary or desirable to vest, perfect or confirm in CFX or CFX Bank all right, title or interest in or to the Marks or the Works.

IN WITNESS WHEREOF, Assignors, intending to be legally bound hereby, have caused this Assignment to be executed in counterparts by their duly authorized officers and their corporate seal to be hereunto affixed and attested by their officers thereunto duly authorized, all as of the day and year first above written.
