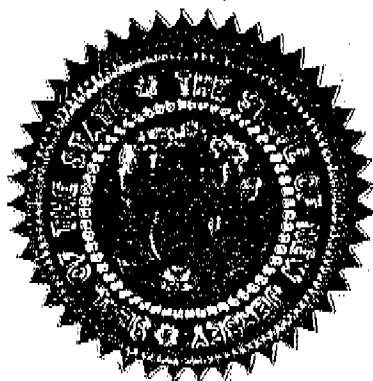

Pursuant to the provisions of 14A:10-7 Corporations, General, of the New Jersey statutes, the undersigned corporation hereby executes the following Certificate of Merger:

1. Hoffmann-La Roche Inc., a corporation organized and existing under the laws of the State of New Jersey, qualified to do business in the State of New Jersey, and owning all of the outstanding shares of HLR Technology Corporation, its wholly owned subsidiary corporation organized under the laws of the State of New Jersey, hereby agrees to the merger of HLR Technology Corporation into Hoffmann-La Roche Inc., which is hereinafter designated as the surviving corporation.
