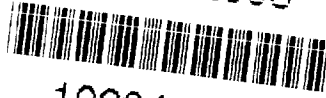

WHEREAS



consents, without any objection, that Assignee solely requests recording of this transfer in any jurisdiction where a recording of this transfer may be affected.




