Pursuant to Florida Statutes §607.1006, the Articles of Incorporation of the above named corporation are hereby amended as follows:


1. **ARTICLE I** is hereby amended to read as follows:

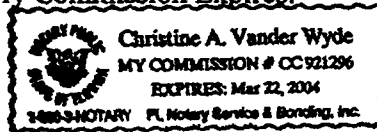

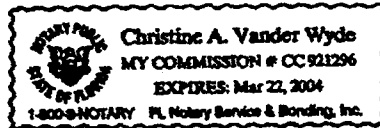
