
TRADEMARK ASSIGNMENT

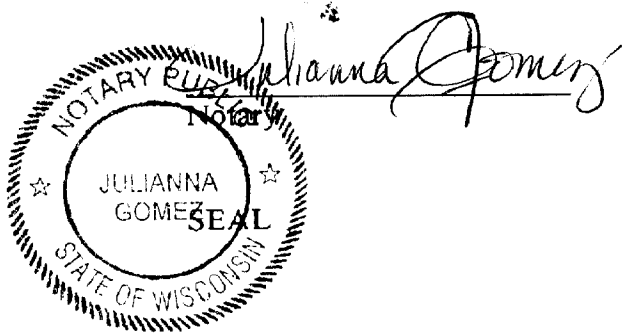
