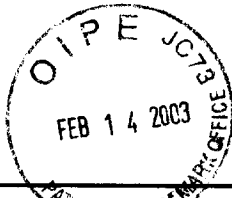

**ASSIGNMENT OF TRADEMARK**

**Background**


2. Assignee accepts the foregoing assignment of the trademark "American Legal Forms."




