TRADEMARK AND GOODWILL ASSIGNMENT

WHEREAS, ASSIGNOR has adopted, used, is using and is the owner of various registered trademarks and registered service marks and the registrations therefore in the U.S.A. as identified in Schedule A attached hereto; and


WHEREAS, ASSIGNEE is desirous of securing, and ASSIGNOR is desirous of granting to ASSIGNEE, an assignment of the registered trademarks and service marks and the registrations therefore owned by ASSIGNOR, as well as the goodwill developed and established, symbolized and associated with the trademarks and service marks as they are used in connection with the sale of goods and services by ASSIGNOR.

NOW, THEREFORE, in consideration for the sum of US \$500, receipt of which ASSIGNOR does hereby acknowledge, ASSIGNOR hereby assigns to ASSIGNEE, all right, title and interest in and to the registered trademarks and service marks and the registrations therefore identified in Schedule A, together with the goodwill symbolized by and associated with the foregoing trademarks and service marks. Such assignments shall include the right to collect damages for all past and future infringements of such trademarks and service marks.


