OF

PERFORMANCE DRILLING WYOMING, a Wyoming corporation, hereby adopts the following Article of Amendment as follows:

ARTICLE I

The name of the corporation shall be HUNTING PERFORMANCE, INC..

1. The amendment was adopted on May 7, 2002 by the shareholders of the corporation.
2. An affirmative vote of two-thirds (2/3) of the shares entitled to vote thereon is required for approval of the amendment to change the name of the corporation.
