ASSIGNMENT

Whereas, ICS Triplex Technology Limited ("Assignee"), a corporation organized and existing under the laws of Great Britain and residing at Hall Road, Heybridge, Maldon, Essex, CM9 4LA, United Kingdom, is desirous of acquiring the entire right, title and interest in, to and under U.S. Trademark Registration 1,413,182 and all other rights in the United States to the trademark covered thereby;


Now, therefore, for One Dollar (\$1.00) and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged by both parties, the Assignor hereby sells, assigns and transfers to the Assignee the entire right, title and interest in, to and under U.S. Trademark Registration 1,413,182, the same to be held by the Assignee and/or any of its successors, assigns or other legal representative, to the end of the term or terms for which said trademark registration of the United States is or may be registered as fully entirely as the same would have been held by the said Assignor if this assignment, sale and transfer had not been made, together with all claims for damages by reason of past infringement of said trademark registration, with the right to sue for, and collect the same.

Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.

Assignor further covenants that Assignee will, upon its request, be provided promptly with all pertinent facts and documents relating to U.S. Trademark Registration 1,413,182 as may be known and accessible to Assignor and will testify as to the same in any litigation or proceeding related thereto and will promptly execute and deliver to Assignee or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce U.S. Trademark Registration 1,413,182 which may be necessary or desirable to carry out the purposes thereof.
