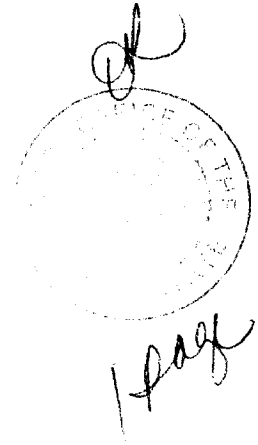

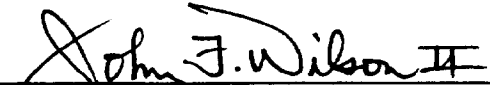
- 1. They are president and the secretary, respectively, of Soaring Eagle Ventures, Inc., a California corporation.
