RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated June 18, 2003 by Harris Trust and Savings Bank, as agent (the "Agent") as hereinafter described;

W I T N E S S E T H:

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, individually and as agent for itself and certain other lenders and Fishing Spirit, Inc. with its mailing address at 1900 18th Street, Spirit Lake, Iowa 51360 (the "Debtor") are parties to a certain Security Agreement Re: Intellectual Property dated February 4, 2000 which was recorded in the United States Patent and Trademark Office on April 11, 2000 at Reel 002122, Frame 0607 (the "Assignment"), pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks and trademark applications listed on Schedule A attached hereto (collectively the "Trademarks"); and

WHEREAS, the Debtor has requested that the Agent release its security interests in the Trademarks and reassign the same to the Debtor;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
