ASSIGNMENT OF TRADEMARKS

After the delivery of this Assignment, the Seller shall upon request of the Buyer execute and deliver such additional documents and instruments, and perform such additional acts, as may be required to secure or perfect the Buyer's right, title and interest in and to the Trademarks assigned to the Buyer hereunder.
