

ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks ("Agreement"), is entered into by and between FLETCHER PAPER COMPANY AND SILVER LEAF PAPER CORPORATION (collectively, "Assignor"), and ALPENA MARC, L.L.C. a Michigan limited liability company ("Assignee").

Whereas, Assignor has obtained certain federal trademark registrations in connection with Trademarks it has adopted, owns and uses;

Whereas, pursuant to a certain asset purchase agreement, certain assets of Assignor are being sold by Assignor to Assignee;

Whereas, Assignor wishes to sell, transfer and assign all of its rights in certain marks to Assignee, as more specifically set forth below.

Now, therefore, for good and valuable consideration, the parties agree as follows:

1. Assignor hereby sells, transfers and assigns to Assignee, free and clear of all liens, claims, options, charges, taxes, security interests, pledges, mortgages or other encumbrances whatsoever, all of its rights, title and interest in all of the trademarks of Assignor and all goodwill of the business of Assignor associated with or symbolized by such trademarks, whether registered or not, including, but not limited to the marks listed on the attached Schedule A.


2. Assignee shall be responsible for filing any and all documents or agreements with the United States Patent and Trademark Office or similar state agency that may be necessary or appropriate to record transfer of ownership of the above trademark registration from the owner to Assignee. Assignor agrees to execute all papers, instruments and assignments requested by Assignee in order to vest all Assignors rights, title and interest in said marks in Assignee, and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.


