

ASSIGNMENT AND TRANSFER OF TRADEMARK AND DOMAIN NAME(S)

This agreement entered into and effective as of this 22nd day of July, 2003 between Cephire Technologies, Inc., of 1255 University Avenue, Rochester, New York 14607 herein referred to as "Assignor" or "Transferor", and Andrea Hadley of 360 East 25th Street, North Vancouver, British Columbia, Canada V7N1A5, herein referred to as "Assignee" or "Transferee".

That Assignor has adopted and is using a mark registered in the United States Patent Office ("USPTO"), Registration No. 2,551,637, on dated March 26, 2003 known as "Netsetgo" ("Trademark") and Assignee is desirous of acquiring such mark and the registration thereof.

That the Transferor is the owner/registrant of the Internet domain names: "netsetgo.com" and "netsetgo.net" and Transferee is desirous of becoming registrant for the domain names herein stated.


Upon receipt of the good and valuable consideration of TWO THOUSAND THREE HUNDRED SEVENTY-FIVE DOLLARS and 00/100 (\$2,415.00 USD) in valid certified funds, Assignor/Transferor does hereby irrevocably assign/transfer to Assignee/Transferee all rights, title and interest in and to said mark, the goodwill of the business symbolized by said mark, along with the registration thereof, the number of which is contained herein, and the domain names set forth herein. Payment shall be made by Assignee/Transferee upon execution of this Agreement and shall be held in escrow by Assignor/Transferor until such time as: 1.) Assignor/Transferor initiates the transfer of above referenced domain names and provides Assignee/Transferee written confirmation of its initiation, and 2.) Assignor/Transferor provides Assignee/Transferee written confirmation of Trademark transfer from USPTO. The parties acknowledge that Assignor/Transferor shall affect such transfer through the USPTO electronic filing/transfer system at a cost of \$40.00 USD and shall not be responsible for any further filings or costs associated with the transfer of the Trademark.


Assignor/Transferor to pay costs, if any, associated with filing standard transfer/registrant name change application to the appropriate registrar. Formal transfer of the domain names shall be initiated upon receipt of the executed Agreement and valid funds set forth above.

Assignee/Transferee shall pay costs, if any, associated with filing all applications for assignment and transfer of the trademark and all fees associated with filing such mark with the United States Patent and Trademark Office (USPTO) or any other similar foreign entity.

The parties agree to use all good faith efforts to complete this transaction in a timely manner and shall provide the other with reasonable assistance to carry out the terms of this Agreement.

WHEREFORE, the parties agree with the terms set forth herein as of the date first set forth above. This Agreement may be executed in two or more counterparts, by facsimile transmission, each of which shall be considered an original, and all of which, taken as a whole, shall constitute one and the same document.
