

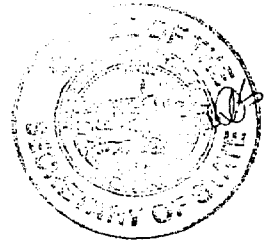

2. The Restated Articles of Incorporation of this Corporation are amended so that Article I thereof shall read in full as follows:


ARTICLE I

The name of the corporation is Grocery Outlet Inc.


3. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the Board of Directors.
