**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

TERMINATION AND RELEASE, dated as of March 27 2003, by General Electric Capital Corporation, a Delaware corporation, in its capacity as Agent for the Lenders (the "Agent"), to Rawlings Sporting Goods Company, Inc., a Delaware corporation (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement, dated as of December 28, 1999, made by the Grantor in favor of the Agent (the "Trademark Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Agent in the Trademark Collateral (as defined in the Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on January 31, 2000 at Reel and Frame Number: 2044/0745; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement (as defined in the Trademark Security Agreement) and the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Release of Security Interest: The Agent hereby terminates, releases and discharges (without recourse, representation or warranty) its Security Interest in the Trademark Collateral (including, without limitation, those items listed on Schedule A hereto), and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
2. Further Assurances: The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
