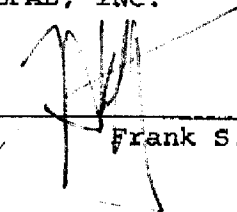


1. Article 3 of the Certificate of Incorporation of CARPCO, INC. is hereby amended, so that as amended, the same shall read as follows:


"ARTICLE 3 - CAPITAL STOCK

The maximum number of shares of stock the Corporation is authorized to have outstanding at any time is 50,500 shares, all of which shall be common voting stock having a par value of \$1.00 per share. All stock issued shall be fully paid and non-assessable."
