FIRST: The name of the corporation is Sorenson Critical Care, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders and directors of the corporation in the manner prescribed by the Utah Revised Business Corporation Act:

Article I is amended in its entirety to read as follows:

The name of this corporation is Sorenson Medical, Inc.

on January 4, 1999

THIRD: The number of voting shares of the corporation outstanding at the time of such adoption was 10,000,000 consisting solely of one class of voting common stock, all of which were entitled to vote thereon.

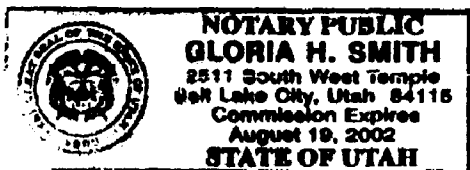
