
ASSIGNMENT OF TRADEMARK

Jeffrey Easterling, being duly sworn, deposes and says:

1. I am a vice president of L C Ind, Inc., a North Carolina corporation. I was formerly a vice president of Signature Works, Inc., a Mississippi corporation.
2. In August 2000, Signature Works, Inc. merged into L C Industries, Inc. becoming a division of L C Industries, Inc. and no longer operated as a separate legal entity.
3. Prior to this merger, Signature Works, Inc. had used the trademarks which are registered in the United States Patent and Trademark Office and which are attached hereto as Exhibit A.
4. As a result of the merger, Signature Works, Inc. assigned and transferred to L C Industries, Inc. in August 2000 all rights, title and interest in and to the said marks, together with the good will of the business symbolized by the marks, and the registrations therefore as set forth in Exhibit A.
5. On August 21, 2002, L C Industries, Inc. amended its certificate of incorporation, changing its name to L C Ind, Inc.


