ASSIGNMENT

WHEREAS, Michael A. Rabinowitz, an individual having an address at 23 W. 73rd Street - PH7, New York, New York 10023 ("RABINOWITZ"), for good and valuable consideration, acquired from GLASNER, on August 15, 2001, the aforesaid trademarks and corresponding trademark registrations, and the goodwill of the business symbolized by the trademarks;

WHEREAS, RABINOWITZ and GLASNER desire to confirm, by confirmatory assignment, the aforesaid acquisition by RABINOWITZ from GLASNER of the trademarks and corresponding trademark registrations, and the goodwill of the business symbolized by the trademarks;

NOW, THEREFORE, GLASNER hereby confirms the assignment unto RABINOWITZ all right, title and interest in and to the trademarks and the corresponding trademark registrations, together with the goodwill of the business symbolized by the trademarks, and all claims for damages by reason of infringement of the trademarks having arisen in the past or arising at some later date, the right to sue for any past, present or future infringement of the trademarks, and the right to collect any royalties under any license agreements heretofore granted or hereafter to be granted.

AND FURTHER, GLASNER hereby agrees to execute, without further consideration, any other documents, additional instruments of assignment, affidavits or applications with respect to the trademarks, and to do all other acts that may be deemed necessary by RABINOWITZ in order to fully secure to RABINOWITZ her interests in the trademarks, including, but not limited to communicating to RABINOWITZ, his heirs, legal representatives, successors and assigns, any facts known to GLASNER relating to the trademarks, and testifying as to the same in any litigation, hearing or proceeding relating to the trademarks.

AND FURTHER, GLASNER hereby covenants that she has not heretofore assigned, mortgaged or permitted any lien or encumbrance to exist with respect to either of the trademarks, or that any such assignments, mortgages, liens, encumbrances and licenses have, as of the date hereof, been reassigned to GLASNER or released, extinguished and/or terminated, and that GLASNER will not henceforth assign, license, mortgage or encumber either of the trademarks, or execute any document to that effect, without prior written consent of RABINOWITZ.
