**ARTICLE THREE**



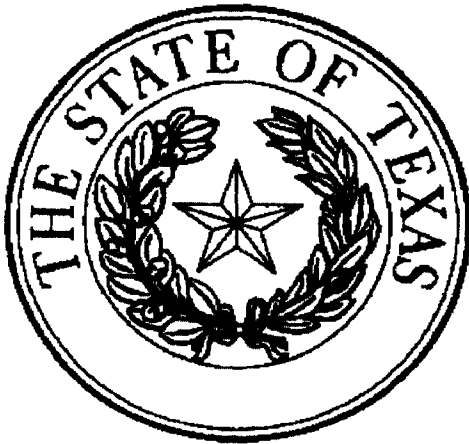
