## ASSIGNMENT OF SERVICE MARK

**WHEREAS**, CARESCIENCE, INC. **NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN**, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee the entire right, title and interest in and to the Mark and the registration thereof for the United States and throughout the world, together with the goodwill of Assignor's businesses connected with the use of and symbolized by the Mark, along with the right to recover for damages and profits for past infringements thereof. Further, Assignor agrees to execute and deliver at the request of the Assignee all documents and instruments, and to perform all other acts, requested by Assignee in order to vest all of Assignee's right, title and interest in and to the Mark.
