THIS AGREEMENT is dated 24th December, 2001 and made

BETWEEN:

- (1) BASS HOLDINGS LIMITED, (the "Assignor"), registered in England and Wales under company number 25675 and having its registered office at 137 High Street, Burton-on-Trent, Staffordshire DE14 1JZ; and
- (2) COORS WORLDWIDE, INC., (the "Assignee"), a Colorado incorporated company, whose principal place of business is 311, 10th Street, Golden, Colorado 80401, USA..

Background:

- (A) The Assignor has agreed to assign the Marks to the Assignee.

The parties agree that:

1. Interpretation

- 1.1 In this Agreement, the following expressions shall have the following meanings:

"Effective Time" means the time at which all the conditions to Completion (as this expression is defined in the SPA) under clause 3 of the SPA, other than clause 3.4, are satisfied.

"Encumbrances" includes any interest or equity of any person (including any right to acquire, option or right of pre-emption), any mortgage, charge, pledge, lien, assignment, hypothecation, security interest (including any created by law) or other security agreement or arrangements or any agreement to create such interest, agreement or arrangement.


"Key Marks" means the registered trade marks details of which appear in schedule 1, including any goodwill or common law rights which are connected with or attached to the same.

"Marks" means:

- (i) all registered trade marks and trade mark applications outside of the Republic of Ireland owned by the Assignor which contain the word CAFFREY'S or which are otherwise used exclusively in connection with the brand of beer known as CAFFREY'S; and
- (ii) all registered trade marks and trade mark applications outside the Republic of Ireland owned by the Assignor details of which appear in schedule 2,

including any goodwill or common law rights which are connected with or attached to the rights described in (i) or (ii) above.

"SPA" means the Share Purchase Agreement of even date between Interbrew UK Holdings Limited, Golden Acquisition Limited, and others relating to the acquisition of the shares in the Assignor and certain of the intellectual property rights of Brandbrew S.A.



2. **Assignment**

2.1 With effect from the Effective Time, the Assignor assigns all its right, title and interest in (i) the Key Marks free from all Encumbrances and with full title guarantee and (ii) the Marks (other than the Key Marks) in each case to the Assignee, including, without limitation:

- (A) all rights to bring any proceedings and obtain any remedy in respect of any infringement of the Marks which has occurred prior to the date of this Agreement;
- (B) all rights to claim priority from the Marks; and
- (C) all rights to any extensions, renewals or amendments of the Marks,

to hold the same to the Assignee, its successors and assigns absolutely.

3. **Consideration**

3.1 In consideration for the assignment in clause 2.1, the Assignee pays to the Assignor the sum of £28 million, receipt of which is acknowledged by the Assignor.

4. **VAT**

4.1 Any sum payable under this Agreement is expressed exclusive of any amount in respect of applicable VAT.

4.2 The Assignee represents and warrants that it belongs in the United States of America for the purposes of Article 16 of the Value Added Tax (Place of Supply of Services) Order 1992 (SI 1992/3121).

5. **Further Assistance**


5.1 The Assignor shall promptly do all such things and execute such documents as may be reasonably required by the Assignee in order:

- (A) to perfect or confirm the Assignee's ownership of the Marks;
- (B) to ensure that the Assignee is registered as the registered proprietor of the Marks with the relevant trade marks registries; and
- (C) to give the Assignee the full benefit of this Agreement.

5.2 The Assignee shall reimburse the Assignor for any reasonable disbursements incurred by the Assignor in complying with the requirements of the Assignee under clause 5.1 except for any costs relating to the execution of any documents by the Assignor.

6. **Law and Jurisdiction**



6.1 This Agreement shall be governed by and construed in accordance with English law.




