ASSIGNMENT OF TRADEMARKS

WHEREAS, iKnowledge, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Parent", and together with its wholly-owned subsidiary, iKnowledge, Ltd., an Alberta, Canada corporation (the "Subsidiary"), the "Seller") is the owner of the entire right, title and interest in and to certain trademark registrations and trademark applications, as specified in Schedule A attached hereto and made a part hereof (the "Trademarks"); and

WHEREAS, Avid Technology, Inc., a corporation organized and existing under the laws of the State of Delaware ("Avid", and together with Softimage Co., a company organized under the laws of Nova Scotia, Canada, the "Buyer"), has acquired the entire right, title and interest in and to certain assets and properties of the Seller, including the Trademarks, pursuant to an Asset Purchase Agreement by and among the Parent and Subsidiary (as Seller), and the Buyer of even date herewith (the "Purchase Agreement"); and

WHEREAS, Buyer desires to acquire the business of the Seller in connection with which Seller has a bona fide intent to use the Trademarks in the pending applications; and

WHEREAS, pursuant to the Purchase Agreement the Parent has agreed to execute such additional instruments as may be necessary or desirable to confirm said acquisition of certain assets by the Purchaser.

NOW, THEREFORE, in consideration of the foregoing, as well as for other good and valuable consideration the receipt of which is hereby acknowledged, the Parent hereby sells, assigns, transfers and sets over to the Buyer, its successors and assigns, in accordance with the terms of the Purchase Agreement, the entire right, title and interest of the Parent in and to the Trademarks, together with the goodwill of the business in which the Trademarks are used and which goodwill is symbolized by the Trademarks and together with that portion of Seller's business in connection with which it has a bona fide intent to use the Trademarks, and including the rights to recover damages, profits and other compensation for infringement, including past infringement, of the Trademarks and to file and obtain renewals thereof.

After the delivery of this Assignment, the Parent shall upon request of the Buyer execute and deliver such additional documents and instruments, and perform such additional acts, as may be required to perfect the Buyer's right, title and interest in and to the Trademarks acquired by the Buyer hereunder.



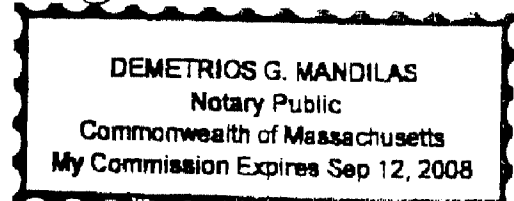

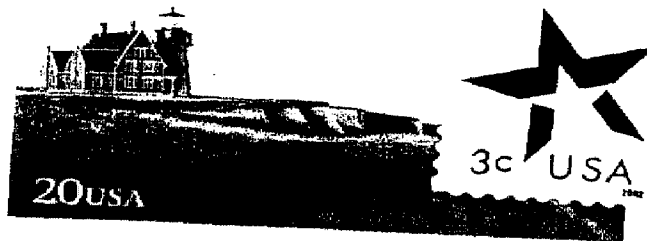
