Please find enclosed three recordation form cover sheets. All of the cover sheets pertain to trademark registrations 2,227,529, 2,230,220 and 2,419,448 (the "Trademarks").

The first cover sheet pertains to the merger of original owner MacDonald Computer Service, a fictitious business name of MacDonald Computer Systems, a California corporation, into ICI Acquisition Corp., a Delaware corporation. A true and correct copy of the merger document, which is entitled Certificate of Merger of MacDonald Computer Service, a California Corporation, With and Into ICI Acquisition Corp. a Delaware Corporation (the "Certificate of Merger"), is attached to the cover sheet. For your information, reference is made in the Certificate of Merger as to the name change of ICI Acquisition Corp. to MacDonald Computer Systems, Inc., a Delaware corporation.


