ASSIGNMENT

Whereas, ABB MAGDA LIMITED ("Assignor"), a corporation (formerly known as ABB August Limited and before that known as Prelamoak Limited) organized and existing under the laws of Great Britain and residing at Orion House, 5 Upper St Martins Lane, London, United Kingdom, is the sole and exclusive owner of U.S. Trademark No. 1,413,182, registered October 14, 1986, by virtue of an Assignment recorded in the U.S. PTO on August 26, 1998, at Reel 001775, Frame 0594;



Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.

Assignor further covenants that Assignee will, upon its request, be provided promptly with all pertinent facts and documents relating to U.S. Trademark Registration 1,413,182 as may be known and accessible to Assignor and will testify as to the same in any litigation or proceeding related thereto and will promptly execute and deliver to Assignee or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce U.S. Trademark Registration 1,413,182 which may be necessary or desirable to carry out the purposes thereof.
