ASSIGNMENT of TRADEMARKS

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is agreed as follows:



Assignor hereby irrevocably assigns and transfers to Assignee all of its right, title and interest in and to the Trademark, and all the good will connected or associated with the Trademark, and which is or will be symbolized by the said Trademark; and all rights and privileges held by Assignor with respect to the Trademark, including without limitation the right to renew and otherwise prosecute the registration of the Trademark in the United States and throughout the world, and all benefits, claims, demands and rights to recover damages or lost profits for past, present and future infringement, if any, of the Trademark in the United States and throughout the world; and all rights and benefits of any licenses Assignor may have granted with respect to the Trademark in the United States or anywhere throughout the world.
2. Assignor hereby consents to recordation of this Assignment with the United States Patent and Trademark Office.
3. This Assignment shall inure to the benefit of, and shall be binding upon, the parties hereto and their respective successors and assigns.




4. This Assignment shall be governed by and construed in accordance with the laws of the State of Maryland.
