
## IP SUPPLEMENT

This IP SUPPLEMENT, dated April 10, 2003, is delivered pursuant to and supplements (i) the Amended and Restated Security Agreement, dated as of October 12, 2001 (as it may be from time to time amended, modified or supplemented, the "**Security Agreement**"), among Wicks Business Information, LLC, ("**Grantor**"), and Bank of Montreal, Chicago Branch, as Administrative Agent for the lenders, in such capacity, "**Secured Party**", and (ii) the Grant of Trademark Security Interest, dated as of October 12, 2001 (the "**Grant**") executed by Grantor. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Grant.

"**Grantor**" grants to Secured Party a security interest in all of Grantor's right, title and interest in and to the Trademark Collateral listed on Schedule A attached hereto. All such Trademark Collateral shall be deemed to be part of the Trademark Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the Grant.
