RELEASE OF SECURITY INTEREST

WHEREAS U.S. BANK, N.A., f/k/a Star Bank, National Association (hereinafter U.S. Bank), a national banking association whose address is 425 Walnut Street, Cincinnati, Ohio 45202 is the grantee of a lien and security interest relating to certain intellectual property referred to in a Collateral Assignment recorded in the United States Patent and Trademark Office on Reel 7534, Frame 0143, said intellectual property being listed on Schedules A, B, and C attached hereto and made a part hereof, and conveyed to U.S. Bank to secure the complete and timely satisfaction of all the obligations (hereinafter Obligations) as defined in a financing agreement dated April 21, 1995 (hereinafter Financing Agreement) between U.S. Bank and B & P Process Equipment and Systems LLC, a Delaware limited liability company (hereinafter B & P); and
