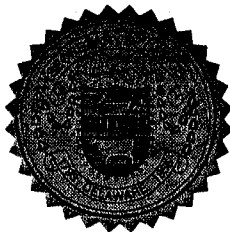

**CERTIFICATE OF AMENDMENT

AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

CHEMCODES INC.**

Pursuant to Section 242 of the General Corporation Law of the State of Delaware, ChemCodes Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware, does hereby certify and set forth as follows:

**FIRST:** The name of the corporation is ChemCodes Inc. (the "Corporation"). The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on June 1, 1998 and was previously amended and restated on June 2, 1999, October 21, 1999 and November 20, 2001 and was further amended on March 20, 2002.

**SECOND:** Resolutions were duly adopted by the Board of Directors of the Corporation setting forth a proposed amendment to the Amended and Restated Certificate of Incorporation of the Corporation and declaring such amendment to be advisable and in the best interests of the Corporation and its stockholders.

**THIRD:** The Amended and Restated Certificate of Incorporation of the Corporation is hereby amended by deleting the text of Article I in its entirety and inserting the following in lieu thereof:

"The name of the corporation is Nuada Pharmaceuticals, Inc. (the "Corporation")."

**FOURTH:** Pursuant to the recommendation of the Board of Directors of the Corporation, in a written consent to action without meeting in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware, the stockholders of the Corporation duly adopted and approved this Certificate of Amendment.

**FIFTH:** This Certificate of Amendment will be effective upon filing.
