## RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST is made as of May 23, 2003 by CRP Investment Partners IV, LLC, a Delaware limited liability company, and CommercialWare Partners, a New York partnership (each, a "Secured Party" and together, the "Secured Parties") and CommercialWare, Inc., a Delaware corporation (the "Grantor"). Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in that certain Amended and Restated Security Agreement by and among the Grantor, the Secured Parties and Capital Resource Partners IV, L.P., a Delaware limited partnership, dated as of June 28, 2002, as the same may be amended from time to time (the "Security Agreement").

WHEREAS, the Grantor granted a continuing security interest in, and continuing lien upon, the trademarks and trademark applications set forth in Schedule A hereto and made a part hereof, for the benefit of the Secured Parties and certain other parties;

WHEREAS, the Secured Parties submitted notice of said grant of security interest in trademarks for recordation with the United States Patent and Trademark Office on or about July 23, 2002; and

WHEREAS, the Grantor has satisfied in full all of the Grantor's obligations under the Security Agreement to the Secured Parties;


