ARTICLES OF AMENDMENT OF

BeComm Corporation

Pursuant to the provisions of RCW 23B.10, the undersigned officer of BeComm Corporation, a Washington corporation, executes the following Articles of Amendment to the Articles of Incorporation of this corporation:

1. Name. The name of the corporation currently registered with the Washington Secretary of State is BeComm Corporation.
2. Text of Amendment. Effective upon filing of these Articles of Amendment with the Secretary of State of Washington, Article [1] is amended in its entirety to read as follows:
