**SECOND AMENDMENT TO AGREEMENT OF GENERAL PARTNERSHIP  
OF BURRLLEN ENTERPRISES OF MARYLAND**

THIS SECOND AMENDMENT TO AGREEMENT OF GENERAL PARTNERSHIP (this "Amendment") is made this 11th day of June, 1999, by and between WYNDHAM INTERNATIONAL OPERATING PARTNERSHIP, L.P., ("WYN"), (formerly known as Patriot American Hospitality Operating Partnership, L.P.) a Delaware limited partnership and PATRIOT GRAND HERITAGE, LLC, a Delaware limited liability Partnership ("PGH") (WYN and PGH hereinafter sometimes collectively, the "Partners").

**Recitals:**

A. [REDACTED]  
("Burrlen") is governed pursuant to an Agreement of General Partnership dated as of December 1, 1991 (the "Agreement").

B. Pursuant to an Assignment of General Partnership Interests dated as of August 15, 1997, the Partners acquired an aggregate one hundred percent (100%) of the partnership interests in Burrlen.

NOW THEREFORE, in consideration of the foregoing recitals, the Partners hereby agree and amend the Agreement as follows:

1. Article I, Section 1.1 of the Agreement is deleted in its entirety, and in lieu thereof is inserted the following:

**Article I**

**Organization and Management**

**1.1 Continuation of Partnership: Place of Business**

The parties hereby continue in general Partnership form, the Partnership, **GRAND HERITAGE IP, GP**, under the provisions of the Maryland Uniform Partnership Act [REDACTED] and its mailing address and principal place of business shall be 1950 Stemmons Freeway, Suite 6001, Dallas, TX 75207, or such other place as the General Partners may from time to time designate.


