**ARTICLES OF AMENDMENT  
OF

Pursuant to RCW 23B.10.060, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Stevedoring Services of America, Inc. (the "Corporation").

SECOND: The Article I of the Corporation's Articles of Incorporation be amended to read in its entirety as follows:


The name of the corporation is SSA PACIFIC
