CONFIRMATORY TRADEMARK ASSIGNMENT

THIS AGREEMENT is entered into nunc pro tunc, effective as of December 20, 2001, between SAFEGUARD BUSINESS SYSTEMS, INC., a Delaware state corporation with a principal place of business at 8585 Stemmons Freeway, Dallas, Texas 75247 (hereinafter "Assignor") and SAFEGUARD INVESTMENT CORP., a Delaware state corporation with a principal place of business at 1105 N. Market Street, Wilmington, Delaware 19801 (hereinafter "Assignee").

WHEREAS, as of the effective date of this agreement the Assignor owns all rights, interest and goodwill in the trademarks listed in the attached Schedule A in the United States, and in the trademark applications and registrations therein listed in the Schedules (collectively referred to as the "Trademarks"); and

WHEREAS, as part of its acquisition of the assets of Assignor, the Assignee is desirous of acquiring and has acquired, and Assignor is desirous of assigning and did assign, and wishes to hereby confirm and assign to Assignee all of its right, title and interest in and all the goodwill appurtenant to the Trademarks and in the applications and registrations therefore.

NOW, THEREFORE, in consideration of and in exchange for the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignor does hereby confirm that it has assigned and does hereby assign unto Assignee all of its right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized thereby, the right to sue for past infringement, the right to prosecute applications and maintain the U.S. Trademark Registrations therefor identified in the attached Schedule A.

2. Assignor shall cooperate with Assignee, at Assignee's request, to execute any and all documents and deeds that are reasonably necessary for giving full effect to the assignment contained herein.
