WHEREAS, Assignee is successor to the business of Assignor, or portion thereof, to which the Marks pertain;





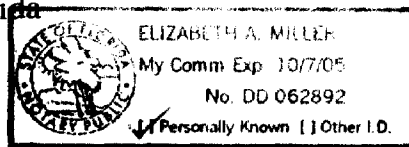
