

WHEREAS, Assignee is desirous of acquiring ½ interest in the Trademark ,



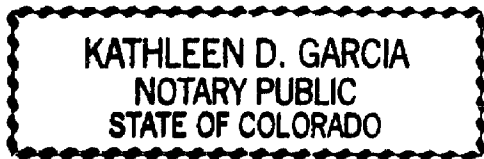
