**1. INTRODUCTION**

- 1.1 Together the Assignors are the proprietors and beneficial owners of the trade marks listed in the schedule to this Deed ("the Trade Marks").

**2. ASSIGNMENT OF THE TRADE MARKS**




**3. GENERAL**



- 3.1 This Deed may be entered into in any number of counterparts and by the parties to it on separate counterparts, each of which when executed shall be an original.
