ASSIGNMENT AGREEMENT WITH RESPECT TO U.S. TRADEMARKS (the "Assignment") made by and among New Jersey Broadcasting Partners, L.P., a New Jersey limited partnership, New Jersey AM Radio, L.P., a New Jersey limited partnership, Northern New Jersey Radio Limited Partnership, a New Jersey limited partnership, High Mountain Tower, Inc., a New Jersey corporation, NNJR LLC, a New Jersey limited liability company, and New Jersey Broadcasting, Inc., a Delaware corporation (collectively, "Assignors"), and The Sentinel Publishing Co., Inc., a New Jersey corporation ("Assignee"), as assignee of Greater Media Radio, Inc., a Delaware corporation ("GMRI"), and Greater Media, Inc., a Delaware corporation ("GMI"), under the Asset Purchase Agreement, dated as of May 8, 2001 (the "Asset Purchase Agreement"), among Assignors, GMRI and GMI. Unless otherwise defined herein, capitalized terms used herein have the meanings ascribed to them in the Asset Purchase Agreement.

WHEREAS, Assignors have adopted, used and are using the service marks and call signs set forth on Exhibit A hereto and incorporated by reference herein, together with any additions thereto between the date of the Asset Purchase Agreement and the date hereof (the "Assigned Marks"); and

WHEREAS, as provided for in the Asset Purchase Agreement, Assignees desire to purchase or acquire all of the right, title and interest of each Assignor in and to the Assigned Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee agree as follows:

1. Each Assignor does hereby sell, assign, convey, transfer and deliver to Assignees all of its right, title and interest in and to the Assigned Marks and the goodwill of the business connected with the use thereof and symbolized thereby, free and clear of all Liens; and all rights, interests, claims and demands, recoverable in law or equity, that such Assignor has or may have in profits and damages for infringements of the Assigned Marks occurring on or after the date hereof, including, but not limited to, the right to compromise, sue for and collect such profits and damages; the same to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by such Assignor if this Assignment had not been made.
2. Each Assignor hereby agrees that it shall at any time and from time to time after the Closing execute and deliver to Assignee such further conveyances, assignments and other written assurances as Assignee may reasonably request in order to vest and confirm in Assignee (or its assignees) the right, title and interest in and to the Assigned Marks to be and intended to be sold, assigned, conveyed, transferred and delivered hereunder.
3. All representations and warranties from Assignors to GMRI and GMI in the Asset Purchase Agreement with respect to the Assigned Marks and the other rights assigned above are incorporated herein by reference.

4. This Assignment shall be governed by, and construed in accordance with, the laws of the United States, in respect to trademark issues and in all other respects including as to validity, interpretation and effect by the laws of the State of New Jersey, without giving effect to the conflict of laws rules thereof.

5. This Agreement may be signed in one and more counterparts, each of which shall be deemed an original and which together shall constitute one and the same instrument.

CERTIFICATE OF INCORPORATION

OF

THE SENTINEL PUBLISHING CO.

THIS IS TO CERTIFY that We, the undersigned, do hereby associate ourselves into a corporation, under and by virtue of the provisions of an act entitled "An act to establish all the public statute law of a general nature of the State of New Jersey, in the form of a revision, consolidation and compilation, to be known as the Revised Statute, Title 14" approved December 20, 1937, and the several supplements thereto and acts amendatory thereof, and do severally agree to take the number of shares of capital stock set opposite our respective names.

FIRST: The name of the corporation is THE SENTINEL PUBLISHING CO.

SECOND: The location of the principal office in this State is at 104 South Main Street, in the Borough of Milltown, County of Middlesex and State of New Jersey.

The name of the agent therein and in charge thereof, upon whom the process of this corporation may be served, is RUTH E. LUERY.

THIRD: The objects for which this corporation is formed are:

A. To carry on business as proprietors and publishers of newspapers, journals, magazines, books and other literary works and undertakings, and also to carry on business as printers, booksellers, bookbinders, papermakers, stationers, engravers, photographers, photographic printers, stereotypers, electrotypers, lithographers, machinists, and mechanical engineers, ink manufacturers, or any other business or manufacture that may seem expedient.

B. The publication and distribution of "The Sentinel", a newspaper covering Milltown, East Brunswick Township and North Brunswick Township, in the County of Middlesex and State of New Jersey.

C. To carry on the business of stationers, printers, lithographers, stereotypers, electrotypers, photographic printers, photo-lithographers, engravers, dis-siners, book-printers, account-book manufacturers, dealers

in parchment, dealers in stamps, advertising agents, designers, draftsmen, ink manufacturers, booksellers, publishers, paper manufacturers, and dealers in the materials used in the manufacture of paper, and dealers in or manufacturers of any other articles or things of a character similar or analogous to the foregoing, or any of them, or connected therewith.

D. To sell, let, lease, mortgage or otherwise dispose of the lands, houses, buildings and other property of the company, to direct the management and sale of all property, buildings and lands, and to transact on commission the business of a real estate agent generally.

E. To purchase, lease or otherwise acquire lands and buildings in this state or elsewhere for the erection and establishment of a manufactory or manufactories and workshops with suitable plant, engines and machinery with a view to manufacture, buy, sell, import and export, or otherwise deal in, either directly or indirectly, through the medium of agents or otherwise, to purchase or otherwise acquire patents, patent rights and privileges, improvements or secret processes for or in any way relating to all or any of the objects aforesaid, and to grant licenses for the use of, or to sell or otherwise deal with any patents, patent rights and privileges, improvements or secret processes acquired by the company; to sell, mortgage, lease or otherwise deal with real and personal property of the company.

F. To acquire and undertake the good will, property rights and assets, and the liabilities of any person, firm, association, or corporation, and to pay for the same in cash, stock or bonds of the corporation, or otherwise, as the Board of Directors may determine.

G. To enter into, make, perform, and carry out contracts of every kind and for any lawful purpose with any person, firm, association or corporation.

H. To borrow money, to make and issue promissory notes, bills of exchange, bonds, debentures and obligations and evidences of indebtedness of all kinds, whether secured by mortgage, pledge, or otherwise,

without limit as to amount, and to secure the same by mortgage, pledge, or otherwise,
 And to sell or otherwise dispose of any and all of the same, all in such manner and upon such terms as the Board of Directors may deem proper.

I. To purchase, hold and re-issue the shares of the capital stock.

J. To conduct business in any of the states, territories, colonies or dependencies of the United States, in the District of Columbia and in any and all foreign countries, to have one or more offices therein, and therein to hold, purchase, mortgage and convey real and personal property, without limit as to amount, but always subject to local laws.

K. To do any or all of the things set forth to the same extent as natural persons might or could do, in any part of the world.

L. To do all and everything necessary, suitable and convenient or proper for the accomplishment of any of the purposes, or the attainment of any one or more of the objects herein enumerated, or incidental to the powers herein named, or which shall at any time appear conducive or expedient for the protection or benefit of the corporation, either as holders of or interested in any property or otherwise.

M. In general to carry on any other business in connection with the foregoing, whether manufacturing or otherwise, and to have and to exercise all the powers now or hereafter conferred by the laws of New Jersey upon the corporation formed under the act herein referred to.

N. It is the intention that the objects and powers specified and clauses contained in this Third Paragraph shall, except where otherwise expressed in said Paragraph, be nowise limited or restricted by reference to or inference from the terms of any other clause of this or any other paragraph in this charter, but that the objects and powers specified in each of the clauses of this Paragraph shall be regarded as independent objects and powers.

ARTICLE The total authorized capital stock of this corporation shall be divided into twenty-five hundred (2500) shares of common stock, all of which shall be without nominal or par value.
