CONFIRMATORY TRADEMARK SECURITY AGREEMENT

CONFIRMATORY TRADEMARK SECURITY AGREEMENT, dated as of July 15, 2003, made by the parties set forth on the signature pages hereto as Grantors (each a "Grantor" and collectively, the "Grantors"), in favor of Fleet Capital Corporation ("Fleet"), as administrative agent and collateral agent (in its capacity as administrative agent and collateral agent, together with any successor, the "Administrative Agent") for (i) each lender now or hereafter being party to the Loan and Security Agreement (as hereinafter defined) as a Revolving Credit Lender or as a Term Loan B Lender (each such lender, including Fleet as a Revolving Credit Lender, together with any successors, individually a "Lender" and collectively the "Lenders") (ii) Silver Point Finance LLC, as agent for the Term Loan B Lenders (together with any successor, the "Term Loan B Agent"), (iii) Fleet National Bank as issuer from time to time of letters of credit issued pursuant to the Loan and Security Agreement (together with any successor, the "Issuing Bank") and (iv) any Revolving Credit Lender or Affiliate thereof to whom Product Obligations (as defined in the Loan and Security Agreement) are owed.

WHEREAS, Jacuzzi Brands, Inc. ("Parent"), Bathcraft, Inc. ("Bathcraft"), Eljer Plumbingware, Inc. ("Eljer"), Gatsby Spas, Inc. ("Gatsby"), Jacuzzi Inc. ("Jacuzzi"), JUSI Holdings, Inc. ("JUSI"), Redmont, Inc. ("Redmont"), Rexair, Inc. ("Rexair"), Sundance Spas, Inc. ("Sundance"), Zurn PEX, Inc., (formerly known as United States Brass Corporation) ("USBC"), USI American Holdings, Inc. ("USIAH"), USI Global Corp. ("USI Global"), Zurco, Inc. ("Zurco") and Zurn Industries, Inc. ("Zurn") (Parent, Bathcraft, Eljer, Gatsby, Jacuzzi, JUSI, Redmont, Rexair, Sundance, USBC, USIAH, USI Global, Zurco and Zurn each, a "Borrower" and collectively, the "Borrowers"), have entered into a Loan and Security Agreement, dated as of July 15, 2003 (as the same may be amended, supplemented, restated or otherwise modified from time to time, the "Loan and Security Agreement") with Administrative Agent, Silver Point Finance LLC, as Term Loan B Agent, Credit Suisse First Boston, acting through its Cayman Islands branch ("CSFB"), as a co-syndication agent, CSFB and Fleet Securities, Inc., collectively, as joint lead arrangers and joint book runners, Bank One, NA, as a co-syndication agent, and the Revolving Credit Lenders and Term Loan B Lenders party thereto from time to time;

WHEREAS, the Grantors have adopted and used in their respective businesses certain trademarks, and each of the Grantors is owner of all right, title and interest in and to its respective trademarks, and applications therefor and registrations thereof;

WHEREAS, the Borrowers, pursuant to the Loan and Security Agreement, and the other Grantors, pursuant to that certain Guarantor Security Agreement, dated as of the date hereof (the "Guarantor Security Agreement"), among such other Grantors and the Administrative Agent, have granted a Lien in favor of the Administrative Agent in all of the Collateral, in each case described therein, including, without limitation, Intellectual Property;

WHEREAS, pursuant to the Loan and Security Agreement, Lenders have agreed to make the Loans (as defined in the Loan and Security Agreement) for the benefit of Borrowers; and

WHEREAS, it is a condition precedent to the obligation of the Lenders to make their respective Loans and other extensions of credit to the Borrowers under the Loan and Security Agreement that each Grantor shall have executed and delivered this Confirmatory Trademark Security Agreement to Administrative Agent;

NOW, THEREFORE, in consideration of the foregoing premises and mutual promises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantors hereby agree as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Loan and Security Agreement.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Each Grantor, pursuant to the Loan and Security Agreement and the Guarantor Security Agreement, as applicable, did and hereby does grant to Administrative Agent, for the benefit of itself, Term Loan B Agent, Issuing Bank, each Revolving Credit Lender, each Term Loan B Lender and each Revolving Credit Lender or Affiliate thereof to whom Product Obligations are owed, a continuing first priority security interest in all of each respective Grantor's right, title and interest in and to the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

(a) all of its right, title and interest in and to its respective trademarks, trademark registrations, and trademark applications (collectively, the "Marks"), including those listed on Schedule I hereto;

(b) all renewals or extensions of the foregoing;


(c) all goodwill of the business connected with the use of, and symbolized by, each of the foregoing; and

(d) all products and proceeds of the foregoing, including, without limitation, any claim or right to petition, sue, or otherwise seek and recover damages, profits and any other remedy (monetary, injunctive, declaratory or other), for any past, present or future infringement, dilution, conversion or misappropriation of, or other injury, offense, violation, breach of duty or wrong relating to any of the foregoing, or any license, agreement, contract or matter relating thereto.

3. SECURITY AGREEMENT. The security interests granted to the Administrative Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Administrative Agent pursuant to the Loan and Security Agreement and the Guarantor Security Agreement. Grantors hereby acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Loan and Security Agreement and the Guarantor Security Agreement, as applicable, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

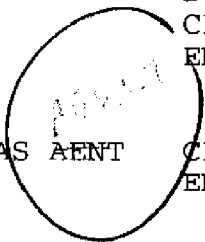
