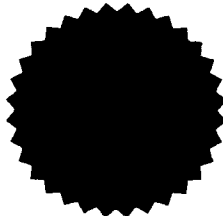

CERTIFICATE OF MERGER

**ARIS CORPORATION,
a Washington Corporation**

INTO

**CIBER, Inc.,
a Delaware Corporation**

Pursuant to the provisions of Section 252 of the Delaware General Corporation Law (the "DGCL") the domestic business corporation and the foreign business corporation herein named do hereby submit the following Certificate of Merger.

1. ARIS Corporation ("ARIS"), a Washington corporation, shall merge with and into CIBER, Inc. ("CIBER"), a Delaware corporation, pursuant to a Second Amended and Restated Agreement and Plan of Merger (the "Plan") effective as of June 14, 2001 (the "Merger Agreement").

2. The Aris board of directors approved the Merger Agreement by resolution on June 13, 2001. The CIBER board of directors approved the Merger Agreement by resolution on June 13, 2001. The Plan was approved, adopted, certified, executed and acknowledged by the stockholders of ARIS in the manner prescribed by law. Pursuant to Section 251(f) of the DGCL, no approval is required by the CIBER stockholders.

2. CIBER, Inc. shall be the surviving corporation.

3. The Certificate of Incorporation of CIBER shall be the Certificate of Incorporation of the surviving corporation without change or amendment.

4. The executed Plan is on file at the principal place of business of CIBER, located at 5251 DTC Parkway, Suite 1400, Greenwood Village, Colorado 80111.

5. A copy of the Merger Agreement will be furnished by CIBER upon request and without cost, to any stockholder of Aris or CIBER.

6. The authorized capital of Aris consists of (i) 5,000,000 shares of preferred stock, no par value per share, and (ii) 100,000,000 shares of common stock, no par value per share.
