2. Article I of the Restated Articles of Incorporation of this corporation is amended to read as follows:

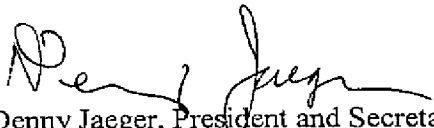
NAME. The name of this corporation is NBOR Corporation.

3. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the board of directors.

4. The foregoing amendment of Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation is 11,221,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
