ARTICLE FIVE


As to each corporation, the number of shares voted for the Agreement and Plan of Merger was sufficient for approval.

ARTICLE SIX


The effective date of the merger shall be the date of filing of these Articles of Merger with the Secretary of State of the State of Colorado.
