TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made and entered into as of this 14 day of July 2003, ("Effective Date"), by and between Waters Investments Limited a Delaware corporation organized under the laws of the State of Delaware, with its principal office at 109 Lukens Drive, New Castle, Delaware 19720 ("Assignee"), and Phase Separations Limited, a corporation organized under the laws of United Kingdom, with its principal office at Deeside Industrial Park, Deeside, Clywd CH4 2NA, United Kingdom ("Assignor").

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner of the Mark in the United States.
