TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, effective the 19th day of December, 2003, is by and between Sunbeam Products, Inc. a Delaware corporation ("Assignor") having its principal place of business at 2381 Executive Center Drive, Boca Raton, FL 33431, and Homer TLC, Inc. 
Assignor shall cease all worldwide use of the Trademark Rights upon execution of this Agreement unless otherwise expressly agreed in writing with Assignee.

IN WITNESS WHEREOF, Assignor has caused this assignment to be executed by its duly authorized officer effective as of the day and year first written above.

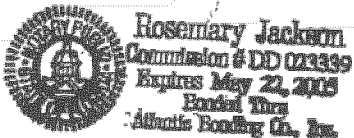


