

NOW COMES Barry S. Chesler, being first duly sworn, on oath deposes and says that he has personal knowledge of the facts herein and will so testify if called to do so under oath before the U.S. Trademark Office, or in a Court of law.

1. I reside at 159 Key Palm Road, <sup>Boca Raton</sup> ~~Deerfield Beach~~, Florida <sup>33432</sup> ~~33432~~.
2. On December 23, 1999, as President of "American Legal Forms, Inc." of Sunrise, Florida, I executed an Assignment (attached as Attachment A) of Trademark Registration No. 1,608,215 from "American Legal Forms, Inc.", to "Hudson Enterprises, Limited of the British West Indies.

3. On December 23, 1999, as President of "Hudson Enterprises, Limited", of the British West Indies, I designated Melvin K. Silverman, Esq. as Hudson's domestic representative before the U.S. Trademark Office. A photocopy of that designation is attached hereto as Attachment B. It is my understanding that Attorney Silverman recorded the December 23, 1999 Assignment with the U.S. Trademark Office on January 17, 2000. A photocopy of that Recordation is attached hereto as Attachment C.

4. The December 23, 1999 Assignment is invalid and should be expunged from the records of the U.S. Trademark Office. "American Legal Forms, Inc." of Sunrise, Florida, (the purported "Assignor") was never the owner of U.S. Trademark Registration 1,608,215, nor had the purported "Assignor," its shareholders, directors, officers, successors, or agents ever have any ownership interest in U.S. Trademark Registration 1,608,215. At no time was American Legal Forms, Inc., of Sunrise, Florida, a predecessor of, a successor of, an assignee of, a subsidiary of, or in anyway associated with the Registrant American Legal Forms Engraving Printing and Office Supplies, Inc. of Chicago, IL.

5. "Hudson Enterprises Limited", the purported "Assignee" of the incorrect Assignment, is not, and never was, the owner of U.S. Trademark Registration 1,608,215. Furthermore, neither the purported "Assignee," nor its shareholders, officers, successors, or agents ever had an ownership interest in U.S. Trademark Registration 1,608,215. At no time was Hudson Enterprises Ltd of the British West Indies, a predecessor of, a successor of, an assignee of, a subsidiary of, or in anyway associated with the Registrant American Legal Forms Engraving Printing and Office Supplies, Inc. of Chicago, IL.

6. I am President of "Made E-Z Products, Inc." of 384 S. Military Trail, Deerfield Beach, Florida, 33442, a corporation existing under the laws of Florida. I formed "Made E-Z Products, Inc.", on July 1, 1999.

9. I claim no interest in the subject registration, either individually or as a duly authorized representative of the aforementioned entities and corporations.
